

Village of Clarksville
Council Meeting Minutes
October 4, 2021

A regular monthly meeting of the Clarksville Village Council was held October 4, 2021 at the Clarksville Village Hall. President Amy Byers called the meeting to order at 7pm.

Other council members present – Trustees Bonnie Main, Joseph Graham, Allen Sheldon, Robin Wahl (virtually), Treasurer Rose Barratt, and Clerk Shari Clark. Absent – Trustees Brad Clark & Patricia Reser.

No public comment.

The minutes of the September 13, 2021 meeting were read and approved.

Motion by Graham and supported by Sheldon to pay monthly bills totaling \$10,874.83 plus incoming Consumers Energy bills and quarterly taxes. Motion passed.

Reports were read by Treasurer Barratt, Street Commissioner Sheldon, Sewer by S.Clark, *ex officio* Planning Commissioner Main, Clerk by S.Clark, and President Byers.

President Byers will research compensation comparisons with other municipalities' boards & commissions.

Motion by Sheldon and supported by Main to amend Leaf Removal Contract with Stahl Lawn Care by increasing annual payment to \$5,500.00 to help offset contractor expense of dumpsite for leaves. All in favor, motion passed.

At no other time should any debris be put in the road and never be placed upon storm drains.

Motion by Sheldon and supported by Graham to **set Trick-or-Treating 5-7 pm in Clarksville on Saturday October 30, 2021.** All in favor, motion passed.

Authorization given to Street Commissioner Sheldon to go ahead and contract for necessary curb & sidewalk repairs at his discretion.

The meeting adjourned at 8:01 pm.
