Village of Clarksville Council Meeting Minutes May 9, 2023

A regular monthly meeting was held May 9, 2023 at the Clarksville Village Hall. President Amy Byers called the meeting to order at 7pm.

Other council members present – Trustees Debra Winkler, Bonnie Main, Patricia Reser, Allen Sheldon, Brad Clark, Treasurer Rose Barratt, and Clerk Shari Clark. Absent Trustee Joseph Graham.

Public comment was heard. Tristen Alderink inquired about zoning regulations seeking customer parking solutions. Judith Transue announced that the Clarksville Farmers Market plans to start June 10th Saturdays 9am-12pm. Seeking more vendors. Details will be posted.

Planning Commissioner applications were reviewed. Moved by Sheldon and supported by B.Clark to appoint Tristen Alderink & Kaitlin Mossner as Village Planning Commissioners. All in favor, motion passed. Both were officially sworn in by Village Clerk for 3-year terms ending November 2026.

The minutes of the April 3, 2023 meeting were read and approved.

Motion by B.Clark and supported by Sheldon to approve monthly bills totaling \$17,372.13. Motion passed.

Reports were read by Treasurer Barratt, Street Commissioner Sheldon, Sewer by B.Clark, *ex officio* Planning Commissioner Main, Clerk by S.Clark, and President Byers.

Moved by Sheldon and supported by Winkler to transfer \$81,015.00 (balance to finish Pedestrian Bridge Project) to Major Street Account and \$14,456.54 to General Fund from Tax Account leaving \$200.00 balance. All in favor, motion passed.

Sheldon will contact T&G Tree Service to trim tree away from electric & cable lines on W.Cross Street in front of Martin residence.

Motion by B.Clark and supported by Winkler to authorize closure of Main Street on August 12, 2023 from 8am – 7pm for the annual Clarksville Ox Roast event. All in favor, motion passed.

Village Clerk will prepare a tax bill enclosure letter to remind residents that inoperable or junk vehicles are in violation of Village Ordinance and lawn grass height limit is 6". All in favor, motion passed.

Motion by Sheldon and supported by B.Clark to support the 2023 Operating Tax Millage to be levied, which reflects no increase, to remain at a rate of 8.3993. All in favor, motion passed.

Motion by B.Clark and supported by Main to reschedule the July regular Council Meeting to Tuesday, July 11, 2023. All in favor, motion passed.

Moved by Sheldon and supported by B.Clark to authorize up to \$200.00 expense towards purchase of a new vacuum for Village Hall. All in favor, motion passed.

Motion by B.Clark and supported by Winkler to accept Simon Inc. \$405.00 estimate to power wash Village Hall. All in favor, motion passed.
