Council Meeting Minutes
December 1, 2025

A regular monthly meeting was held December 1, 2025 at the Clarksville Village Hall. President Tristen Alderink called the meeting to order at 7pm.

All council members present – Trustees Debra Winkler, Bonnie Main, Brad Clark, Allen Sheldon, Scott Briggs, Brian Reser, Treasurer Rose Barratt, and Clerk Shari Clark.

No Public comment.

The minutes of the November 3, 2025 meeting were read and approved.

Moved by Sheldon and supported by Briggs to pay monthly bills totaling \$14,696.93 plus incoming Consumers bills. All in favor, motion passed.

Reports were read by Treasurer Barratt, Street Commissioner Sheldon, Sewer by B.Clark, *ex officio* Planning Commissioner Main, Clerk by S.Clark, President Alderink, and Playground Committee Sheldon & Winkler.

Moved by Main and supported by Reser to authorize \$200.00 expense to purchase custom signs posting Village Playground hours open dawn to dusk. Motion passed.

RESOLUTION #2025-04 APPOINTMENT OF VILLAGE PLANNING COMMISSIONERS was offered for adoption by Council Member Brad Clark and supported by Debra Winkler. Upon roll call the following voted "Aye": Brad Clark, Brian Reser, Scott Briggs, and Debra Winkler. Abstain: Allen Sheldon and Bonnie Main. Motion passed.

Moved by B.Clark and supported by Reser to approve 2026 meeting calendars. Council meetings will be held 1st Mondays (*except September will be held Tuesday September 8th*) and Planning Commission meetings will be held the 3rd Thursdays each month. All in favor, motion passed. All meetings begin 7pm at Clarksville Village Hall. Two meetings between the boards will be held jointly: the Village Council will attend the February 19th Planning Commission meeting and the Planning Commissioners will attend the September 8th Council meeting.

Moved by Winkler and supported by Reser to reappoint Brad Clark as President pro tempore. All in favor, motion passed.

Moved by Winkler and supported by Main to appoint standing committees as follows; Finance, Budget, & Grants Committee – Rose Barratt & Tristen Alderink, Health and Public Safety Committee – Tristen Alderink & Bonnie Main, Legislative Committee – Shari Clark & Allen Sheldon, Streets, Sidewalks, & Street Lighting Committee – Allen Sheldon & Brad Clark, Downtown Revitalization and Business Development Committee – Tristen Alderink & Scott Briggs, and Parks and Recreation Committee – Debra Winkler, Allen Sheldon, and Brian Reser. All in favor, motion passed.

The meeting adjourned at 7:40 pm.
